

# KIRKWOOD SCHOOL DISTRICT COMMUNITY SURVEY EXECUTIVE SUMMARY JANUARY 2021



#### INTRODUCTION

Beginning on Jan. 6, 2021, an electronic community-wide survey was placed into the field to further the Kirkwood School District's effort to engage and listen to the community. The goal of the survey was to understand the community's perceptions of and priorities for the District regarding a variety of topics including facility needs and a possible future bond proposal.

To better gauge residents' opinions, anyone living or working within the Kirkwood School District, or attending a Kirkwood school, was asked to share their input to provide District leaders with important feedback regarding the District.

Residents were informed of the survey by mail, email, the District's website, and social media. A copy of the survey was published in the *Webster Kirkwood Times* and paper copies of the survey were distributed in the community. Nearly 3,000 surveys were completed, meaning all questions were answered.

Survey results were weighted to reflect District demographics. Two weighting criteria were applied. The first was a 50/50 ratio of male to female completed surveys. The second was weighting age demographics to more accurately reflect the age distribution in the District. Results of all survey questions are included in the overview of data and crosstabs at the end of this report. In these reports, those who only answered the first two survey questions, and a handful of respondents not living in the district, were excluded from the analysis.

In the analysis, survey results were also examined weighting by gender and parent of a District student status. The results were virtually identical to those from weighting by gender and age. The gender/age weighting was used for the results reported in this Executive Summary because they can more easily be compared to a District survey completed in 2015.

The following information is provided to assist in ongoing planning and facility improvement discussions by Kirkwood School District leadership.

#### **GRADING THE DISTRICT**

Nearly three-fourths (73.9%) of the respondents graded the Kirkwood School District an "A" or "B." Relatively few respondents graded the schools D-F (5.8%). When asked about the leadership of the District, about half (50.7%) indicated they somewhat or strongly disagreed with the statement "I don't trust the leadership of the district."

## STATEMENTS ABOUT THE DISTRICT

Respondents were asked several statements that, "some people might make about public education" and asked how strongly they agreed or disagreed with each. Presented below are the statements that had among the highest level of **combined strongly and somewhat agreed** responses.

#### **VALUE FOR TAXES**

Respondents answered a few questions specifically related to the issue of taxes within the Kirkwood School District. Compared to many districts in which we've surveyed, anti-tax sentiment in the Kirkwood School District is comparatively low with only 44.5% agreeing that "people like me" can't afford to pay higher property taxes. We use this question on many surveys and "agree" responses are often between 60 and 70%. Presented below is the **combined strongly and somewhat agreed.**

#### DISTRICT JOB PERFORMANCE

Respondents were asked to rate the District's performance in a number of different areas. The District's classroom teachers received high marks, as did the District's efforts to maintain its buildings and provide up-to-date school facilities. This means concerns about facilities were mostly limited to space/crowding issues and not the overall physical or functional condition of the buildings.

A high percentage (67.3%) indicated approval for the District's response to the COVID-19 pandemic. A majority of respondents (65.7%) indicated they thought the District did an excellent/good job communicating with residents, though a lower percentage (51.8%) felt decisions were made in an open and transparent manner. Presented below are the top three topics with the **combined excellent/good job performance rating.**

## SUPPORT FOR A NEW ELEMENTARY SCHOOL

Respondents were asked how they felt about the construction of a new elementary school near the intersection of Dougherty Ferry and Lindemann roads. The responses indicate a very divided community on this issue, with 45.4% favoring construction of the new school, and 43.5% opposing the new school. Interestingly, the District's bond proposal on the June 2020 ballot, that included this proposal for a new school as a central feature, received a 45.65% positive vote — virtually the same percent as support for a new school measured in this survey.

# **DISTRICT FACILITY AND ACADEMIC PROGRAM NEEDS**

Respondents were shown a list of possible improvements being considered for Kirkwood School District facilities. They were asked to rate each, on a seven-point scale, indicating their priority. Presented below is the **combined top/high priority rating** (the combination of a 5, 6, or 7 on the seven-point priority scale).

## ADDRESSING CURRENT CROWDING AND SCHOOL BUILDING CONDITIONS

Respondents were asked to evaluate features of a possible bond proposal to address District facility needs. These features included various conditions such as overcrowding and identified District needs. The complete list of these features is included in the crosstabs attachment at the end of this document. Presented below are key **combined much more/somewhat inclined to support** statements, and provide information on which facility needs the community think are most important to address.

#### ADDRESSING FACILITY NEEDS WITH A POSSIBLE BOND ISSUE

Respondents were asked to evaluate ten statements that people could make about a possible bond proposal for facility improvements. For each, they were to indicate if they agreed or disagreed. Presented below are the statements along with **percent agree (the total of strong agree and somewhat agree)**.

- When looked at in total, respondents are proud of their District and its history.
- Large majorities agree that something needs to be done to address crowded conditions in their schools.
- While they don't believe that there are substandard conditions in the schools, they support improvements to keep in step with best practices in facility improvements as they relate to curriculum and instruction.

### FINDINGS SPECIFIC TO FUTURE BOND PROPOSAL

Respondents were asked about a possible bond proposal at two times in the survey — once very early in the survey (the second question) and then again toward the end of the survey.

At the beginning of the survey, 57.8% indicated they would strongly favor or favor a bond issue proposal to address facility needs with 27.8% being opposed or strongly opposed and 14.5% being undecided. It is our experience that anything other than "favor" is actually "opposed" in analyzing surveys of this type. Following questions that introduced some facts and figures about the possible bond issue, respondents were again asked about it toward the end of the survey. On this reconsideration question, support slightly increased to 61.2%, with 27.1% being opposed or strongly opposed and 11.8% undecided.

Benchmark results (the first time the question was asked) are almost identical to the 4/7's vote needed for a successful proposal. It has been our experience that numbers like this can move 5 to 10 percentage points in either direction depending on communications and activities between now and election day, and whether or not there is organized opposition to the proposal.

In December 2021, Creative Entourage conducted an online survey of households in the Kirkwood School District. The purpose of the survey was to better understand area residents' perceptions of and priorities for the District. The results below reflect 2,995 responses, and the data was weighted by gender and age. Complete results of every question asked are noted below.
