# The iPad Self-Funded Insurance Program Grades 3-8

The Kirkwood School District offers an opportunity to families who wish to enroll in a self-funded insurance pool that will cover the cost of accidental damage or theft of a district-provided device.

#### **Terms and Conditions**

You will be responsible for protecting your assigned iPad from loss or damage. If an accident or theft should occur, the Kirkwood School District will waive your responsibility for the financial loss, subject to a deductible for multiple occurrences, as outlined below. In exchange for this damage waiver, Kirkwood requires payment into a self-funded insurance program.

The iPad waiver fee for 2023-2024 is \$20 (\$10 for students receiving free or reduced lunch), with a coverage period of August 1, 2023 - August 22, 2024.

## **Payment**

Payment may be made through a My School Bucks account using Visa, MasterCard, American Express, Discover or checking and savings accounts. Please visit <a href="https://www.myschoolbucks.com">www.myschoolbucks.com</a> to create and/or log into an account. While not preferred, payment via cash or check may be made in person in a school's main office.

### **Self-Funded Insurance Structure**

There is no deductible for the first and second covered claims per year *if families have paid* for the self-funded insurance program. Families who do not opt into the self-funded insurance program are asked to pay repair fees according to the table below.

#### **Excluded Losses**

Certain conditions not covered by this damage waiver include: 1) any dishonest, fraudulent, malicious or criminal acts, 2) any loss to software, data, documents, music, videos, recordings or other personal information that the student has placed on the device, 3) additional loss caused by the failure to use all reasonable means to protect the device after it has been damaged, 4) disappearance of the device without submitting a copy of a formal police report to school authorities and 5) any use not in accordance with District policies and procedures.
